The Special Call Council Meeting was called to order by Mayor Clyde "Rog" Rogers at 6:00 p.m. Present at call were Mayor Clyde Rogers, Councilmember Calvin Cowen and Councilmember Shirley Clopton. Councilmember James Waddell and Councilmember Greg Rensberger were absent. Also present at call was Town Administrator Cameron Fant.

In compliance with the Freedom of Information Act, notice of this meeting was submitted by fax and e-mail to the Spartanburg Herald-Journal and the Greer Citizen on June 21, 2018. The agenda was posted on the front door of the Duncan Police Department and Town Hall on Thursday June 21, 2018.

Mayor Rogers gave the Invocation and Mayor Rogers led the Pledge of Allegiance.

At 6:03 p.m. Mayor Rogers opened the Floor to the public for a Public Hearing relating to the Fiscal Affairs of the Town of Duncan, South Carolina, Making Appropriations, Therefore, Levying Taxes, and to Provide for an Effective Date July 1, 2018 thru June 30, 2019. Town Administrator Cam Fant took the Floor to inform Council that the Agenda sent out to the new media and posted at Town Hall had a start time of 4:00 p.m. Fant said that the paper had run the start time at 6:00 p.m. Fant said he was at Town Hall at 4:00 and no one showed up. After that Mayor Rogers asked if anyone from the Public wanted to make a comment. No one made a comment. At approximately 6:05 Mayor Rogers closed the Public Hearing.

Next Mayor Rogers called Fant to the Floor for the SECOND READING OF ORDINACNE NO. 20180612-1, an ORDINANCE RELATING TO THE FISCAL AFFAIRS OF THE TOWN OF DUNCAN, SOUTH CAROLINA, MAKING APPROPRIATIONS THEREFORE, LEVYING TAXES, AND TO PROVIDE FOR AN EFFECTIVE DATE July 1 2018 thru June 30, 2019. Fant took the Floor and reminded Council that this was the Second Reading. Fant then told Council he had made very few and non-material changes to the Budget since the First Reading. Fant took a minute to go thru some of the changes. After that Mayor Rogers asked for a Motion to approve the Second and Final reading of Ordinance No. 20180612-1. Councilmember Cowen made a Motion and a Second was made by Councilmember Clopton. The Vote to Approve for the SECOND READING OF ORDINACNE NO. 20180612-1, an ORDINANCE RELATING TO THE FISCAL AFFAIRS OF THE TOWN OF DUNCAN, SOUTH CAROLINA, MAKING APPROPRIATIONS THEREFORE, LEVYING TAXES, AND TO PROVIDE FOR AN EFFECTIVE DATE July 1 2018 thru June 30, 2019 passed 3-0.

Next Mayor Rogers called Fant to the Floor for the SECOND READING OF ORDINACNE NO. 20180612-2, an ORDINANCE TO AMEND ORDINANCE NO. 201705-1 RELATING TO THE FISCAL AFFAIRS OF THE TOWN OF DUNCAN, SOUTH CAROLINA, MAKING APPROPRIATIONS THEREFORE, LEVYING TAXES, AND TO PROVIDE FOR AN EFFECTIVE DATE July 1 2017 thru June 30, 2018. Fant took the Floor and reminded

Council that this was the Second Reading. Fant then told Council that no changes had been made to this budget amendment since the First Reading. After that Mayor Rogers made a Motion to approve the Second and Final reading of Ordinance No. 20180612-2. Councilmember Clopton made a Second. The Vote to Approve for the SECOND READING OF ORDINACNE NO. 20180612-2, an ORDINANCE TO AMEND ORDINANCE NO. 201705-1 RELATING TO THE FISCAL AFFAIRS OF THE TOWN OF DUNCAN, SOUTH CAROLINA, MAKING APPROPRIATIONS THEREFORE, LEVYING TAXES, AND TO PROVIDE FOR AN EFFECTIVE DATE July 1 2017 thru June 30, 2018 passed 3-0.

At approximately 6:16 p.m. Mayor Rogers asked for a Motion to close the Special Call Meeting. A Motion to close was made by Councilmember Cowen. His Motion was Seconded by Councilmember Clopton. The Vote to close the Special Call Meeting passed 3-0.
